Subject: Registration, Evaluation, Authorization and Restriction of Chemicals (REACH)/1907/2006/EC

Dear Valued Customer:

Please be advised that Heyco Products Corp., together with our material suppliers is actively engaged in the evaluation of our products potentially affected by REACH. There are some specific aspects of REACH that apply to all Heyco Products that we wish to call your attention to:

Under REACH, Heyco's products are classified as "articles". An article is defined in REACH as "an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition." Currently, articles are <u>exempt</u> under REACH.

There are two basic exceptions to the article exemptions, these are:

- Substances that are intentionally released from the article.
- Substances on the list of Substances of Very High Concern (SVHC).

Heyco is confident that none of the substances are intentionally released in the parts we manufacture. Also, based on the information provided to us by our raw material suppliers and our knowledge of the composition of these products, our products do not contain any of the restricted substances, as defined in Article 67, Annex XVII (including all amendments), Annex XIV and including substances with dates of inclusion as follows:
